I agree to participate in real estate commission rebates as listed below. The understanding is that I am not "stuck" with a non-performing REALTOR® and have a choice of REALTORS® from BHIF's network in the event I want to be referred. In the event I have a particular REALTOR® I want to use, BHIF will refer me to that REALTOR®. Also, BHIF agrees that the payment of real estate commission rebates due me will come from a portion of the BHIF referral fee collected at the time of the successful closing on my real estate transaction(s). There is no extra cost for me to participate in this rebate.

There is a process that needs to be followed in order to participate in the rebate program. I agree to first contact BHIF to discuss referral details before talking to any real estate agent and agree to allow BHIF Relocation Group to act as a referral agent for listing and/or buyer real estate agents through BHIF's Home Referral Network. If BHIF refers me, I am then able to receive real estate commission rebates. The BHIF designated real estate broker is a REALTOR®. With the rebate program I will receive as much as \$1,700 in cash rebates, depending on the sale and/or purchase price of my home(s). Homes valued in excess of \$400,000 will have larger rebates. I will notify my Personal Relocation Counselor at 888 339-3130 that I am ready to proceed.
